Announcement by Councillor Tony Newman, the Leader of the Council – Additional Funding for Regeneration of the Borough The Council is receiving over £3m of funding in partnership with the GLA as part of the regeneration of the Borough. The funding is returned to the Council from the new homes bonus. It will be targeted at the regeneration of Thornton Heath district centre.

Announcements by Councillor Mark Watson, Cabinet Member for Safety and Justice

1. Services for Civil Partnerships and Same Sex marriages
Recently the legislation changed enabling same sex couples to be
married. Under the new legislation those who have a Civil
Partnership under the previous arrangements wishing to change
from the civil partnership to a marriage cannot do that with a

ceremony but have to sign a certificate of conversion which is one of the least romantic occasions imaginable.

In order to make this more inclusive and celebratory, people can now have an event here with family and friends by a ceremony to renew their vows in the Town Hall which makes it more romantic event than just signing a piece of paper.

2. Active Communities Fund

The Active Communities Fund gives support to small scale initiatives to help communities become more resilient and develop their own ideas and do more for themselves. We have increased the amount available for the active communities fund in 2015/16 from £100k to £150k. We have listened to the community and have introduced new micro grants up to £1k with a much simpler process for people to apply for these funds. We really want to encourage a greater community response to things that really matter to them.

The priorities for the fund this time are:

- 1. Developing active communities by creating innovative ways of promoting a sense of belonging and cultural activites.
- 2. Giving young people the opportunity to reach their full potential

- and the confidence to express themselves.
- 3. Helping people care for one another's health and well-being.
- 4. Developing innovative ways to tackle food and fuel poverty and support greater access good quality welfare benefits and other advice..
- 5. Developing a community response to combatting domestic abuse and sexual violence.
