## 1. **RECOMMENDATIONS**

1.1. Cabinet is asked to consider recommendations arising from the meeting of the Scrutiny and Strategic Overview Committee on 9<sup>th</sup> September 2014 and 17th December 2014 and to take these into account in drawing up final proposals for submission to the Council.

## 2. EXECUTIVE SUMMARY

The Scrutiny and Strategic Overview Committee considered a pre-decision report relating to the Budget Process at its meeting on 9<sup>th</sup> September 2014 and the Council Budget 2015/16 at its meeting which was held on 17th December 2014 as it is empowered to do under Part 4C of the Constitution.

The Committee has made recommendations to Cabinet which it is asked to consider before final decisions relating to the Budget 2015/16 are made. The recommendations and the minutes comprise the comments of the committee on the proposals published by the Leader and cabinet.

# 3. DETAILS

The Scrutiny and Strategic Overview Committee, at its meeting on 9<sup>th</sup> September 2014 (Minute number A44/14), noted that the Council has been successful in controlling revenue expenditure over a number of years and in this context resolved to:

• Recommend to Cabinet that in order to be certain of achieving maximum value for money, more rigour might need to be applied to capital expenditure.

The Scrutiny and Strategic Overview Committee, at its meeting on 17th December 2014 (Minute number A61/14), resolved to:

- Recommend to Cabinet that it (cabinet) consider a report on the proposed closure of the Purley Pool at the February Council Tax cabinet meeting before drawing up proposals for submissions to Council and that the report should seek to address the concerns and questions raise by the Scrutiny committee and concerns of pool users(and their expert report), and take into account the practicalities of the effective use of Waddon pool as an alternative (including access by public transport, parking and capacity) and any health implications arising from the closure
- Recommend that Cabinet should provide more information to Council about the implications of the proposal to limit further member referrals to the Planning Committee to major applications only (as referrals from MPs and GLA Members have already been limited) before any decision is taken.
