CORPORATE PRIORITY/POLICY CONTEXT: Effective outcome based commissioning and prudent financial transactions contribute to all corporate priorities.

AMBITIOUS FOR CROYDON & WHY ARE WE DOING THIS: The Council's commissioning strategy (2012 -2015) sets out the approach to commissioning and procurement and puts delivery of outcomes at the heart of the decision making process. As the Council develops more diverse service delivery models, it is important to ensure that our contractual and partnership relationships are not only aligned to our corporate priorities but also represent value for money for citizens and taxpayers, contributing to the growth agenda for Croydon. The contracts (awarded or recommended for award) and partnership arrangements included in this report will support the Council to achieve the Ambitious for Croydon outcome "to be innovative and enterprising in using available resources to change lives for the better."

FINANCIAL SUMMARY: There are no direct costs arising from this report.

1. RECOMMENDATIONS

- 1.1.1 approve the continuation of the Insurance London Consortium arrangements by way of the Council entering into a new agreement under s.101 of the Local Government Act 1972 for that purpose, for a further term of five years with the London Boroughs of Camden, Haringey, Harrow, Islington, Lambeth, Sutton, Tower Hamlets, and the Royal Borough of Kingston upon Thames;

- 1.1.2 approve that the London Borough of Croydon continues to act as the Accountable Body for those purposes including the finalisation of the new s.101 Agreement.
- 1.2 The Cabinet is requested to note:-
- 1.2.1 The list of delegated award decisions made by the Director of Strategy Communities and Commissioning, between 30/09/2015 and 19/10/2015
- 1.2.2 Contract awards recommended to the Cabinet for approval which are the subject of a separate agenda item and referenced in section 4.2 of this report.

2. EXECUTIVE SUMMARY

- 2.1 This is a standard report which is presented to the Cabinet, for information, at every scheduled Cabinet meeting to update Members on:
 - Contracts anticipated to be awarded under delegated authority from the Leader by the nominated Cabinet Member, in consultation with the Cabinet Member for Finance and Treasury and with the Leader in certain circumstances, before the next meeting of Cabinet. As at the date of this report there are none;
 - Delegated contract award decisions made by the Director of Strategy Communities and Commissioning since the last meeting of the Cabinet:
 - Contract awards to be agreed by the Cabinet at this meeting which are the subject of a separate agenda item;
 - Partnership arrangements to be agreed by the Cabinet at this meeting which are the subject of a separate agenda item;
 - Delegated award decisions made by the nominated Cabinet Member and the Cabinet Member for Finance and Treasury in respect to the Revolving Investment Fund (RIF) since last reported to Cabinet. As at the date of this report there are none;
 - Property acquisitions and disposals to be agreed by the Cabinet or the Cabinet Member for Finance and Treasury (as appropriate) either as part of this agenda or before the next meeting of Cabinet. As at the date of this report there are none.
- 2.2 This report additionally seeks approval of a delegation to enable continuation of the insurance consortium arrangements through which the Council procures relvant insurance cover.

3. DETAIL

- 3.1 Further to a recommendation of the Corporate Services Committee on 15 September 2010, the Cabinet Member for Housing, Finance and Asset Management approved the establishment of the Insurance London Consortium (ILC) under S101(5) of the Local Government Act 1972. The ILC coordinates market engagement of insurance services, including procurement activity, but each Council enters into separate contracting arrangements. Utilising the combined purchasing powers of the constituent members, the ILC has secured competitive rates for insurance cover over its initial term and has achieved efficiencies through pooling of resources and shared professional fees. In addition it has provided opportunities for collaboration and sharing of expertise across the nine local authorities.
- 3.2 Cabinet is asked to agree a delegation to the Cabinet Member for Finance and Treasury in relation to the continuation of the Insurance London Consortium (ILC) beyond its initial five year term. A Section 101 agreement to jointly discharge functions covers these arrangements. This type of agreement is not a contract as envisaged by the existing delegations from the Leader to the Cabinet Member, hence a request for a specific delegation in this matter. Whilst in itself the renewal of the consortium arrangements is not a contractual matter, a number of insurance contract awards will flow from the arrangements.
- 3.3 Section 4.1 of this report lists the delegated award decisions made by the Director of Strategy, Communities and Commissioning, between 30/09/2015 to 19/10/2015.
- 3.4 Section 4.2 of this report lists the contract award recommended to the Cabinet for approval at this meeting. This contract award is the subject of a separate agenda item and is itemised in this report for information only.
