
1. Detailed Considerations

1.1 The application was received by the Planning & Environment Department on 2 April 2012.

- 1.2 The application was duly advertised in the Croydon Guardian, no objections were received.
- 1.3 The Police licensing Officers, Food Safety team, Planning, Highways, Croydon BID and parking services divisions were invited to comment on this application, no objections have been received.
- 1.4 The measurements outlined above have been checked and agreed by an Enforcement Officer during a site visit.
- 1.5 A temporary licence was issued to the applicant which is valid until 3.10.2012 pending the committee's decision. A copy is attached as Appendix D5.
- 1.6 If the street designation order and street trading licence are granted, the applicant will provide a barrier around the tables and chairs in accordance with condition 6 on the temporary licence.

- 1.7 There is 1 other nearby premises in Brighton Road who currently holds a street trading licence No 910-912 tables and chairs. The position of this site is marked with a * and the site applied for is shaded on the attached map Appendix D6.
- 1.8 If the application for a street trading licence is granted the applicant will be invited to apply for a Street Trading Licence which will then be valid for a year.






Non Transport for London Maintained Roads
