**Measurements:** The measurement from the front of the entrance to the other side of the alleyway is 6.2 m narrowing at one end to 4.9 m The applicant has applied for a trading area of 2 m, which leaves a clear width of 4.2 m narrowing to 2.9 m. Matthews Yard is maintained by Croydon Council and the required clearance width is 2 m.

A total length of 8m is also applied for.



- 1.1 The application was received by the Planning & Environment Department on 24 May 2012. A copy of the application is attached as Appendix E4.
- 1.2 The application was duly advertised in the Croydon Guardian, no objections were received.
- 1.3 The Police licensing Officers, Food Safety team, Planning, Highways, and parking services divisions were invited to comment on this application, no objections have been received.
- 1.4 The measurements outlined above have been checked and agreed by an Enforcement Officer during a site visit.
- 1.5 A temporary licence was issued to the applicant which is valid until 24.11.2012 pending the committee's decision. A copy is attached as Appendix E5.
- 1.6 If the street designation order and street trading licence are granted, the applicant will provide a barrier around the tables and chairs in accordance with condition 6 on the temporary licence.

- 1.7 There is no other nearby premises in Matthews Yard who currently hold a street trading licence. The site applied for is shaded on the attached map Appendix E6.
- 1.8 If the application for a street trading licence is granted the applicant will be invited to apply for a Street Trading Licence which will then be valid for a year


