
1. Detailed Considerations

1.1 The application was received by the Planning & Environment Department on 3rd May 2012.

A copy of the application is attached as Appendix I4.

- 1.2 The applicant was advised by letter that as this site is on London Road and in accordance with Council Policy, the Committee will generally be minded to refuse any further requests for designation, due to 'additional sites would have a detrimental impact on the safe and convenient passage of pedestrians in that part of the street', but will consider each request on its merits. A copy of the letter is attached as Appendix I5
- 1.3 The application was duly advertised in the Croydon Guardian, no objections were received.
- 1.4 The Police licensing Officers, Food Safety team, Planning, Highways, and parking services divisions were invited to comment on this application, no objections have been received.
- 1.5 The measurements outlined above have been checked and agreed by an Enforcement Officer during a site visit.

- 1.6 A temporary licence was issued to the applicant which is valid until 3.11.2012 pending the committee's decision. A copy is attached as Appendix I6.
- 1.7 There are 3 other nearby premises in London Road who currently hold street trading licences .No 786a household goods, 808 fruit and vegetables, 814 hardware. The position of this site is marked with a * and the site applied for is shaded on the attached map Appendix I7.
- 1.8 If the application for a street trading licence is granted the applicant will be invited to apply for a Street Trading Licence which will then be valid for a year


