1. Detailed Considerations

1.1 The applicant has held a street trading licence at another shop (1362 London Road) for a number of years where he displayed household goods. He has recently moved his business 1350 London Road.

- 1.2 1350 London Road was designated and a licence granted for street trading in June 2012 and a temporary street trading licence, to permit tables & chairs, was issued pending that decision. However, not long after the site was designated, the previous occupier ceased trading and therefore the full street trading licence was not physically issued to him. A copy of the temporary licence is attached as Appendix B1.
- 1.2 The applicant has submitted an application for a street trading licence for the new shop, to reflect the change of ownership and also a variation application.
- 1.3 The total width of the highway is 6.2m, the street trading licence which was granted by the committee in June 2012 was for a display width of 2.2m and a length of 5.4m.
- 1.4 A variation application has been submitted by the new owner to vary the display from tables & chairs to household goods and to increase in the length of the licensed area from 5.4 m to 8m. A copy of the variation form is attached as Appendix B2.
- 1.5 A photograph of the shop showing the area of the previously licensed display of tables and chairs is attached as Appendix B3.
- 1.6 The Police Licensing officer, Food Safety team, Planning, Highways, and parking services divisions were invited to comment on this variation application, no objections have been received.
