


1. Detailed Considerations


- 1.1 The application was received by the Development & Environment Department on 4 July 2014. A copy of the application is attached as Appendix C4.
- 1.2 The application was duly advertised in the Croydon Guardian, no objections were received.
- 1.3 The Police Licensing Officers, Food Safety team, Planning, Highways, and Parking Services divisions were invited to comment on this application, no objections have been received.
- 1.4 The measurements outlined above have been checked and agreed by an Enforcement Officer during a site visit.
- 1.5 A temporary licence was issued to the applicant which is valid until the **4.1.2015** pending the Committee's decision. A copy is attached as Appendix C5.
- 1.6 There are 3 other nearby premises in Brighton Road who currently hold a street trading licence, 910-912 tables and chairs, 920 tables and chairs and 950 tables and chairs. These sites are marked with an X and the position of the site applied is shaded on the attached map Appendix C6.
- 1.7 If the application for a street designation order is granted the applicant will be invited to apply for a Street Trading Licence which will then be valid for a year.


