# **MINUTES - PART A**

# A6 London Local Authorities Act 1990: Applications for Street Designation Orders and Application for Variation to Street Trading Licence

The Committee considered the application for a street designation order for **12a Suffolk House**.

The Licensing Manager introduced the item and led the Committee through the report and associated appendices. The application was for tables and chairs to be located outside the property - the measurements were fully set out in the report and associated appendices. The tables and chairs were located on a Council maintained highway and there were no other designated licences in use in the immediate vicinity. Advertisements had been placed in the local newspapers with no objections received, and no representations were received from any responsible authorities.

In response to a question from the Committee, the Market Inspector confirmed that the property above the premises was designated office space.

The Applicant had been informed of the meeting but was not present.

## The Committee **RESOLVED**:

- 1.1 To designate 12a Suffolk House for the purposes of street trading.
- 1.2 To grant a street trading licence to the Applicant.

The Committee considered the application for a street designation order for a trading location on **North End, outside the entrance to the Centrale Shopping Centre, 21 North End**.

The Licensing Manager introduced the item and highlighted that the application was for a freestanding one metre by one metre section of North End and not attached to or directly outside a specific shop. This required two metres of clear space around the designated site for passage. The Applicant had previously held temporary licences for the location but was now applying for a permanent one. There 2 of 68

had been no comments received from any consultees on the application.

In response to questions from the Committee, the Licensing Manager provided the following information:

- A temporary licence would specify the days in which trade would take place, whereas the one year permanent licence did not.
- The carousel trader on North End operated using daily licences.
- The costings for a yearly licence were clarified for the Committee, the licences were costed on £4 per square metre per day. This was worked out as a lower rate compared to the neighbouring borough of Sutton. The fee structure had been agreed and considered at a previous Committee meeting.
- The de-designation of a site from street trading purposes would have to be considered by the Committee, and the reasons for de-designation could be found in statute.

The Applicant was present and delivered submissions to the Committee. The Applicant stated that the business had been operating in Croydon for a long time and did so through the previously available six month temporary licences to allow for flexibility of trading dates. The new licence procedure no longer allowed for this and therefore it was more commercially viable to obtain a permanent one year licence than daily licences.

The Solicitor advised the Committee that it had discretion over whether to grant a designation but the decision must be based on the principles of fairness, proportionality and reasonableness.

An objector was present on behalf of Croydon BID and, in addition to the written submissions previously circulated, delivered oral submissions to the Committee against the application. It was stated that the objection was not against the Applicant itself, which was noted as a long standing business in the borough. The objection was to the precedent the application would be setting for the designation of further areas of North End for street trading. This could create difficulties with the planned regeneration of the area as part of the Westfield Hammerson development.

The Solicitor advised the Committee that each application must be taken on its own merits, unless there was a relevant policy framework to take into consideration.

## The Committee **RESOLVED**:

- 2.1 To designate a trading location on North End, 1 metre x 1 metre in dimension, outside the entrance to the Centrale Shopping Centre, 21 North End for the purposes of street trading.
- 2.2 To grant a street trading licence to the Applicant.

The Committee considered the application for a street designation order for **The George Public House**, **17-21 George Street**.

The Licensing Manager introduced the item and highlighted to the Committee that the application was looking to increase the trading area that had already been granted by the Committee at a previous meeting. There was no request to change the hours of operation, only the area of operation – with a lengthways extension by an additional metre at one end of the current site. The highway in question was maintained by the Council. The application had been advertised with no objections received. No representations were received from any responsible authorities.

In response to a question from the Committee, the Licensing Manager confirmed that the issue of the proximity of the site to the tram stop had been raised when the Committee considered the original licence for the site and any related health and safety concerns had been addressed by officers at the time.

The Applicant was present, and in response to questions from the Committee stated the following:

- The purpose of the extension was to provide for a segregated smoking zone and a non-smoking tables and chairs area outside.
- The table and chairs would be displayed on a weather dependent basis.
- Investment had been made in new outside furniture and there
  would be an emphasis on ensuring that it would not be
  dominated by smokers as was previously the case.
- There was no space for table umbrellas or canapes, therefore the seating area would be uncovered.

# The Committee **RESOLVED**:

- 3.1 To designate The George Public House, George Street for the purposes of street trading.
- 3.2 To grant a street trading licence to the Applicant.

The Committee considered the application for a street designation order for **281 South Norwood Hill**.

The Licensing Manager introduced the item and drew the Committee's attention to the appendices that detailed the measurements of the proposed site. The application had been advertised in the local newspaper and no objections had been received. There had been no representations received from any consultees.

The Market Inspector explained to the Committee that the first picture in Appendix D1 showed the tables laid out in compliance with of 68

the site designations however the second photo showed a layout that was non-compliant.

In response to questions from the Committee, the following was stated:

- The measurement was taken from the bottom of the barrier pole base disk to the edge of the pavement curb.
- There was nothing to stop customers consuming alcohol on the premises, as consumption was not a licensable activity.

The Applicant was present and made submissions to the Committee. It was stated that there was no table service outside, customers were required to take their consumables with them if they wished to sit outside. The road opposite the café was quiet and there had currently been no issues raised by customers since the temporary licence had been in effect.

In response to questions from the Committee, the Applicant provided the following information:

- There was a residential property above the flat and there was a good relationship with the tenant.
- It was possible for customers to fit on the chairs despite the erected barrier; no concerns had been raised by customers.
   Although it was tight, it was the best compliant option available.
- The Applicant had a very good relationship with the customers and would have no issues in ensuring compliance with the requirements of the licence.
- The barrier was a rope-clip system which could be easily removed and re-applied to allow access to the chairs.
- Allegedly, the previous owner of the café displayed tables & chairs but did not hold a trading licence, this application was to ensure the business was legally complaint.

The resolutions as contained in the report were put to the vote.

The following Members voted in favour of the resolutions: Avis, Canning, Chatterjee, Bernadette Khan, Mohan, Neal, Quadir, Winborn, and Young.

The following Members voted against the resolutions: Clouder and Justice.

# The Committee thus **RESOLVED** to:

- 4.1 To designate 281 South Norwood Hill for the purposes of street trading.
- 4.2 To grant a street trading licence to the Applicant.

At 7.43pm Councillors Chatterjee and Quadir left the meeting.

The Committee considered the application for a variation of a street trading licence for **Pizza Hut**, **59-61 North End**.

The Licensing Manager introduced the item by stating that the site had already been designated as noted in the report. The application before the Committee was to vary that licence in relation to extension of the opening hours; no other variation was requested. It was confirmed that no representations had been made by consultees.

In response to a question from the Committee, the Licensing Manager confirmed that there were no other street designations in the immediate vicinity of the premises.

The Applicant was present at the meeting. In response to a question from the Committee, the Applicant stated that the extended opening hours allowed for the street furniture, stored inside the restaurant, to be displayed in the morning and thus allowing for cleaning of the premises to be an easier task.

## The Committee **RESOLVED**:

5.1 To grant the application to vary the terms of the existing street trading licence for 59-61 North End as stated in the report.

# A7 Gambling Act 2005 - Setting of Premises Licence Fees

The Licensing Manager introduced the item and stated that under the Gambling Act 2005 the Council was the licencing authority for issuing premises licences for betting shops, family entertainment centres, adult gaming centres and bingo halls.

As part of this process, the Council was entitled to set fees for such premises licences on the principle of cost recovery. There were maximum limits for such fees. The papers submitted for this item set out the proposed fees to be set, and the calculation process in coming to those figures was explained to the Committee. Appendix 1 illustrated the current fees and Appendix 2 the proposed new fees.

In response to questions from the Committee, the following was stated:

- The statement of principles for Licensing would be reviewed in 2018.
- Adult gaming centres were defined as premises containing higher stake and prize money category betting machines.
   Family gaming centres only provided for low stake and prize money category machines.
- There is no provision in the legislation or statutory guidance to create cumulative impact zones for betting shops, however there had been changes to planning law that regulated the conversion of some premises to betting premises.
- The fees set by other London boroughs were provided for the Committee

 It was explained that "reinstatement" of a licence referred to situations where a current licence lapsed due to the holder becoming insolvent or passing away.

The Committee **RESOLVED** to adopt the new fee structure as stated at Appendix Two of the associated report.

The Committee were informed that, in consultation with the police, three additional conditions to the application where added which were detailed on paragraph 1.4 of Appendix A. At the hearing, the applicant also offered, as part of their application, an additional condition that could be attached to the application if the Sub-Committee were minded to grant it. The wording of the offered condition read as follows:

"Between the hours of midnight and 6am the cashier will hand to any customers a leaflet reminding the customer that the premises are in a residential area, to keep noise to a minimum, leave the premises quietly and respect the privacy of the local residents."

The Sub-Committee, having reference to the licensing objectives under the Licensing Act 2003, the statutory guidance and the Council Licensing Policy **RESOLVED** to **grant** the variation to the premises licence on the basis that they were satisfied that it would support the licensing objectives to do so. In particular, the Sub-Committee noted that the police had agreed conditions with the applicant in support of the crime and disorder prevention objective and the applicant had amended their application to include those conditions in support of the prevention of crime and disorder and the following condition in relation to the promotion of preventing public nuisance objective:

"Between the hours of midnight and 6am the cashier will hand to any customers a leaflet reminding the customer that the premises are in a residential area, to keep noise to a minimum, leave the premises quietly and respect the privacy of the local residents."

# A5 LICENSING ACT 2003 – APPLICATION FOR PREMISES LICENCE: 52 Chapel View, CR2 7LF

The Licensing Sub-Committee considered the Application for a Premises Licence at 52 Chapel View, South Croydon, CR2 7LF and the representations received as contained in the report of the Executive Director 'Place'.

The Sub-Committee also considered the verbal representations and 11 of 68

made at the hearing by the applicant for the premises licence.

The Sub-Committee, having reference to the licensing objectives under the Licensing Act 2003 and the Council Licensing Policy **RESOLVED** to Grant the premises licence at 52 Chapel View, South Croydon, CR2 7LF.

The reason for the decision was on the basis that the Sub-Committee were satisfied that it would support the licensing objectives to do so. In particular, the Sub-Committee noted that the applicant explained the issues regarding the police raid and that the raid occurred in the flats above the premises. The applicant further explained that measures were installed in the premises over 10 years ago to prevent break ins into the premises. The Sub-Committee also took notice that the Police and the Council's noise pollution team had not objected to the application and the issue of anti-social behaviour was not proved.

# A6 LICENSING ACT 2003 – APPLICATION FOR PREMISES LICENCE: 409-411 Beulah Hill SE19 3HD

The Licensing Sub-Committee considered the Application for a Premises Licence at 409-411 Beulah Hill, London, SE19 3HD and the representations received as contained in the report of the Executive Director 'Place'.

The Sub-Committee also considered the verbal representations made at the hearing by the applicant for the premises licence holder and their representative.

The Sub-Committee, having reference to the licensing objectives under the Licensing Act 2003 and the Council Licensing Policy **RESOLVED** to Grant the premises licence at 409-411 Beulah Hill, London, SE19 3HD.

The reason for the decision was on the basis that the Sub-Committee were satisfied that it would support the licensing objectives to do so. In particular, the Sub-Committee were satisfied that the applicant had appropriate training arrangements for its staff, had a challenge 25 policy and had appropriate CCTV cameras installed to support the promotion of the four licensing objectives.

The Sub-Committee also noted that in line with paragraph 4:10 of its Licensing Policy and 14:19 of the Guidance issued by the Secretary of State commercial demand or competition was not a matter for a licensing authority when discharging its licensing functions. The Sub-Committee also took notice that the Police and the Council's noise pollution team had not objected to the application and the issue of anti-social behaviour was not proved.

## 1. RECOMMENDATIONS

1.1 The Committee is asked to determine whether to designate the sites detailed at Appendix A - E for the purposes of street trading and if designated to then determine whether to grant a street trading licence to the site.

# 2. EXECUTIVE SUMMARY

2.1 The purpose of this report is to seek the Committee's decision on the proposal to designate five sites in the Borough as 'licence streets for street trading and the granting of street trading licences under the provisions of the London Local Authorities Act 1990 (as amended.)

# 3. DETAIL

- 3.1 The London Local Authorities Act 1990 (as amended) (The Act) provides a legislative framework to control street trading in the Borough. Trading in respect of services as well as goods comes within the scope of the Act.
- 3.2 Licensed street trading may only take place in streets or parts of streets which have been formally designated as "licence streets".
- 3.3 Appendices A-E to this report provide details of the designation applications. The applicants have been invited to attend the meeting.
- 3.4 If the sites outlined in Appendix A-E are formally designated as 'licence streets by the committee then the committee will decide whether to grant street trading licences
- 3.5 The measurements of the individual display areas as outlined in Appendices A-E will allow for the required 2 metre clear distance between the edge of the display and the kerb which is the requirement for roads maintained by Croydon Council or the required 2.8 metre clear distance for roads maintained by Transport for London (TfL), whichever is applicable.

## 4. CONSULTATION

4.1 Applications A–E were duly advertised in the Croydon Guardian and brought to the attention of the police, planning, highways, parking services and the food & safety team.

# 5 FINANCIAL AND RISK ASSESSMENT CONSIDERATIONS

# 5.1 The effect of the decision

There are no direct financial implications as a result of this report.

## 5.2 Risks

If an applicant is refused a licence on any of the grounds mentioned in paragraph 7.2 (a) - (g) he/she will have the right of appeal to the Magistrates' Court against the decision. The decision of the Committee may also be subject to Judicial Review.

An appeal against a decision of the Committee or a Judicial Review of the application process may present financial risks to the Council with regard to any award of costs against it.

# 6. COMMENTS OF THE SOLICITOR AND MONTORING OFFICER

# **LICENCE STREET**

- 6.1 If the borough council considers that street trading should be licensed in an area, they may pass a resolution designating any street within the borough as a "licence street" in accordance with Section 24 of the Act.
- 6.2 The first decision which has to be made is whether to designate the particular location as a "licence street", which in turn would permit the consideration of a licence application.
- 6.3 Under Section 24 of the Act, the designation of a location as a "licence street" is at the discretion of the Committee and this decision is not subject to any direct appeal.
- 6.4 Each application must be considered on its own merits.

## 6.5 STREET TRADING LICENCE

If a site has been designated as a 'licence street', the committee must then decide whether to grant a licence to trade at that site – a 'street trading licence'.

# 7. GROUNDS FOR REFUSAL

- 7.1 Under Section 25(4) of the Act, a street trading licence:
  - (a) shall not be granted:
  - (i) to a person under the age of 17 years; or
  - (ii) except where the application is made by a company incorporated under the Companies Acts, or by a partnership, for a licence to carry on ice- cream trading to a person, on a corresponding day, days or time, who holds a street trading licence in any other licence street granted under this Part of the Act but nothing in this paragraph shall prevent the renewal of such a licence; or

- (iii) except where the application is made by a company incorporated under the Companies Acts, or by a partnership, for a licence to carry on icecream trading to a body corporate or to an unincorporated association;
- (iv) in respect of an application for a licence which is not a temporary licence to trade in a street which is not a licence street; or
- (v) where the street to which the application relates is a street in respect of which the borough council have by resolution passed under Sub-Section 1) (b) of Section 24 of this Act, specified a class of articles or things, or services which they will not prescribe in any street trading licence and the grant of the licence would be contrary to any of the terms of that resolution;
- (b) shall not be granted unless the borough council are satisfied that there is enough space in the street for the applicant to engage in the trading in which he desires to trade without causing undue interference or inconvenience to persons or vehicular traffic using the street.
- 7.2 Under Section 25(6) of the Act, the Council may refuse an application on any of the following grounds:
  - (a) that there are enough traders trading in the street or in any street adjoining the street in respect of which the application is made in the goods in which the applicant desires to trade;
  - (b) that the applicant is on account of misconduct or for any other sufficient reason unsuitable to hold the licence;
  - (c) that the applicant is an individual who has without reasonable excuse failed personally to avail himself of a previous street trading licence;
  - (d) that the applicant has at any time been granted a street trading licence by the borough council which was revoked or could have been revoked on the grounds that he had refused or neglected to pay fees or other charges due to them in respect of the licence;
  - (e) that the applicant has failed to provide or to identify suitable or adequate premises for the storage of any receptacles or perishable goods in which he proposed to trade when street trading is not taking place;
  - (f) that the application is for the grant (but not the renewal) of a street trading licence; and
    - (i) the only available position is in that part of the street which is contiguous with the frontage of a shop; and
    - (ii) the articles, things or services mentioned in the application are sold or provided at the shop;

- (g) that

- 13.2 When hearing an application, the proceedings of a non-judicial body such as the Licensing Committee, as opposed to an actual Court, need not meet the full requirements of A6 where there is a right of appeal from the Licensing Committee to a Court that <u>does</u> meet the full A6 standards <u>and</u> can consider all aspects of the case (even if that does not include a full re-hearing of the facts).
- 13.3 So, while it is good practice to make a hearing before the Licensing Committee as A6 compliant as possible, it will not be a breach of the HRA if it is not. Further, the hearing of all applications are subject to the principles of Natural Justice and the requirement for decisions to be 'Wednesbury reasonable'.

- 1.5 A weekly temporary licence has been granted to the applicant pending the committee hearing. An example copy is attached at Appendix E5.
- 1.6 Other sites nearby holding a street trading licence are marked on the map at Appendix E6.
- 1.7 This site has previously been designated for street trading (provision of tables & chairs) by the Licensing Committee in 2008 and a street trading licence is in place. The measurements of the area already designated are

- length 6.75m, width 1.5m and height 1.5m. A copy of the current street trading licence is attached at Appendix E7.
- 1.8 If the application for a street designation order is granted the applicant will be invited to apply for a Street Trading Licence which will then be valid for a year.







Below is the position of Surrey House Residents Association.

We represent the residents of the building of which the pub is situated on the ground floor. The outside seating area is now directly beneath the properties. The building compromises of 30 flats with in the region of 50 residents.

Generally there has been a great deal of anger from the residents at the councils decision to grant the licence to the pub without first consulting the residents directly.

The licence itself has allowed the customers of the pub to utilise the outside space directly beneath the flats for gathering in large groups with the consumption of alcohol. This has led to an increase in noise and anti-social behaviour late into the evening. Previously a situation which was barely tolerable with disturbances from the pubs customers has now escalated and is causing a detrimental affect on the residents.

In addition to the increase in noise there have been fights and the consumption / handling of illegal substances. All of which the residents have evidence for.

There are also issues with regards to the health of the residents with smoke from cigarettes and illegal substances rising into the flats above.

Generally the pub is causing a detrimental impact as it stands on the residents lives and we intend to submit a licence review to the council for the premises. A freedom of information request from the council and the police has demonstrated the level anti-social behaviour that has been caused by this establishment.

It is for the above reasons that we urge the council to deny a permanent licence to this establishment as it stands for the outside area.

The residents have not been keeping a diary of the specifics but they have been contacting the council regarding noise issues.

In addition since the seating area and additional opening times were agreed the noise late at night and first thing in the morning with regards scraping and dragging of objects has increased and become pretty unbearable for those on the lower floor. I believe this may be related to chairs tables etc but may not directly relate to your jurisdiction.

The increase in noise is now every day especially on sunny days. Nothing that you could report to the police but enough to cause discomfort to the residents and a change from the relatively peace (evenings especially) that they had before.

I also now have a Freedom of Information act report from the police which details many incidents over the past two years at the premises including violence, drugs etc... the outside seating area now means that has spilled out into the street and is now affecting residents even more. Three violence against persons incidents were recorded by the police this year. This obviously does not include incidents that did not relate in case files being opened.

In short the pub in general (which the outside area has now exacerbated) is adversely affecting residents lives in the block.


