ORIGIN OF ITEM:	At the beginning of the 2015-2016 municipal year, the chairs of the Children and Young People Scrutiny Sub-Committee agreed to give a group of young people the opportunity to lead questioning at one of its meetings in order to gain a greater understanding and experience of local democracy and encourage other young people in Croydon to get involved in local democracy

## 1. EXECUTIVE SUMMARY

The Children and Young People Scrutiny Sub-Committee is invited to co-opt the young people in attendance to the sub-committee to lead questioning at its 17 November meeting.

## 2. BACKGROUND

2.1 Further to the instruction by Scrutiny chairs to explore the possibility of engaging young people in Croydon more deeply in local democracy, contact was made with Croydon College, and, following a presentation at the college regarding this proposed initiative, a group of seven young people undertook to

take part in the project. Additional students joined this project after Croydon College's Enrichment Fayre of 9 September.

- 2.2 At meetings of the group, young people agreed that the topic for this meeting should be *housing for the young*. Areas to be focused on are as follows:
- Availability of low cost housing for young people
- The regulatory framework re housing for young people
- Systems for vetting young people including a possible interview process
- Dealing with youth homelessness and its impact
- The provision of advice to young people regarding their rights re housing
- The provision of advice to young people on how to manage a property and a tenancy
- 2.3 The Children and Young People Scrutiny Sub-Committee is invited to co-opt the young people in this group ahead of the 17 November meeting.
