The London Mayor's Transport Strategy

- Sets the strategic direction for next 20 years
- Integration of land use and transport, and the provision of a robust and resilient public transport network
 - Aims to reduce dependency on cars in favour of increased walking, cycling and public transport use





The London Mayor's Transport Strategy (MTS)

• Overarching aim is 80% of all journeys in London to be made by sustainable means (foot, by cycle or public transport) by

2041. Croydon is currently at 49%.

Three priority themes for delivery:

- Healthy streets and healthy people
- A good public transport experience
- New homes and jobs



Third Local Implementation Plan (2018)

- Sets out Croydon's priorities and proposals to support and implement:
- The Mayor of London's Transport Strategy (MTS) objectives and priorities;
- London Plan growth objectives; and the Corporate Plan and Local Plan ambitions,
- To deliver 'Good Growth', ensuring that a future Croydon and London are not just bigger but are even better places.



Third Local Implementation Plan (2018)

Outlines a 3 year programme of investment that delivers:

- Improvements to walking and cycling routes;
- The rollout of electric vehicle charging infrastructure and car club vehicles;
- A Healthy Schools Neighbourhoods programme;
- Virtual hub and electric bike share schemes;



Third Local Implementation Plan (2018) continued

- Improved bus accessibility in suburban areas;
- Vision Zero Safer Streets schemes (zero killed or serious accidents by 2041)
- Traffic reduction strategies;
- A Liveable Neighbourhood proposal to reconnect Old Town with adjacent residential areas, reversing the severance caused by the ring road



Croydon Local Plan

Policy SP8: Transport and Communication

- Airport City Enhance Croydon's sub regional role
- Actively manage the pattern of urban growth and the use of land to make the fullest use of public transport and colocate facilities to reduce the need to travel
- Support improvement in the borough's Wi-Fi and broadband to reduce the need to travel, support inward investment and improve economic competitiveness
- Improve conditions for walking and enhance the pedestrian experience



Croydon Local Plan continued

- Provide new and improved cycle infrastructure
- Prioritise tram infrastructure provision and network improvements
- Encourage rail infrastructure provision and network improvements
- Encourage bus infrastructure provision and network improvements
- Land used for public transport and land required to facilitate future transport operations will be safeguarded




Croydon Local Plan continued

- Enable the delivery of electric vehicle charging infrastructure throughout the borough
- New development to contribute to the provision of electric vehicle charging infrastructure, car clubs and car sharing schemes
- Encourage car free development in Centres, where there are high levels of PTAL
- Seek to limit parking spaces and aim to reduce the overall amount of surplus car parking spaces in the Croydon Opportunity Area



Transport Vision for Croydon 2015

- Make 'transport work for Croydon'
- People and places at its heart
- Safer, more accessible routes
- Safer and more pleasant environment
- More interesting places to draw
- Pedestrians and cyclists back to Croydon's streets
- Change people's decisions around how they choose to travel







Croydon's Cycle Strategy 2018-2023

We are cycling very little, yet have the highest potential for cycling of all London boroughs

- Explores the barriers to cycling
- Safety, Culture, Topography and Availability
- Seeks to remove barriers through training, awareness, improved infrastructure, 20mph limits, safer construction & deliveries, buses and trams and cycle parking and hubs

We will raise these specific issues with colleagues in Highways and Parking who are managing the projects and report back to this group on this issue.

Speed restrictions may be a possible solution to road safety issues but need to be part of an evidence based approach which analyses each location and takes account of the local context. As part of the Cabinet paper on the Local Implementation Plan (LIP) a programme of road safety improvements is underway. Collison data has been analysed and Stage 1 reviews to include the top 30 clusters in the borough are being conducted. Where possible road safety projects will be integrated into other projects within the LIP. An anticipated 10 road safety schemes would be taken forward in 2024/25.
