**M** Describe the steps you intend to take to promote the four licensing objectives:

**a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)**

The premise will be primarily used for packaging and distribution. The public will have zero access to the property. The noise created by this process will not be heard off site. Children will have no access to this property. There are no alternative uses for this premise with regard to the business. It has been ensured that the premise is extremely secure and can only be assessed by certain individuals.

**b) The prevention of crime and disorder**

There are only two doors that access the garage and both are securely locked. The keys for each door are stored inside the residential premise which itself is securely locked. Only two keys exist for each door. The company will not advertise its location or address. From the outside there will be no clues as to the contents of the garage. In the 20 years the residents have lived in the property, the garage has never been broken into.

**c) Public safety**

The public will have zero access to the premise. All members of the residential property are over 18 and are upstanding citizens. The use of the garage poses no threat to the safety of the public or to the safety of the residential household.

**d) The prevention of public nuisance**

There will be very little noise created by the use of this premise. Deliveries will be taken during the working hours (9:00-18:00). Packaging will be done during the same working hours and may on occasion go outside. However, the packaging process will not make sufficient noise to be heard off the premise anyway.

**e) The protection of children from harm**

No children will have any access to the premise. All members of the residential household are over the age of 18. The premise is very secure and cannot be assessed by children.
