
## The national context: an ongoing and enduring pandemic

- Worsened in recent weeks
- Vaccination rollout and expansion of test and trace
- Increased enforcement role for local government
- Resilience impact on staff and services (prioritising services to most vulnerable)
- Economic impact on businesses
- Financial impact on residents



## The national context: an ongoing and enduring pandemic

The latest national lockdown is starting to cause the number of new covid-positive cases to fall in Croydon as across London. This is driven by lower positivity rates and not reduced testing.



Despite this fall, the weekly incidence rate is still very high with latest figures of 923.3 per 100,000 – the 13<sup>th</sup> highest rate in the country (by UTLA), this is the 7<sup>th</sup> highest rate in London




## The national context: an ongoing and enduring pandemic

Deaths involving covid-19 are starting to increase




To date (1 Jan 21) there have been a total of 612 deaths of Croydon residents involving COVID-19





## What is Croydon Renewal Improvement Plan – quick recap

- Deliver fundamental transformation of the Council's systems of internal control, governance and management where required to underpin financial recovery
- Provide assurance against a number of key issues, including:
  - External Auditor's Report in the Public Interest (RIPI)
  - Strategic review of the Council's companies
  - Improving the Council's general fund and earmarked reserves
  - Improving the Council's governance arrangements
  - Implementing the recommendations of the independent finance review
  - Any recommendations from the MHCLG non-statutory Rapid Review team



## Key updates:

- The Council submitted our capitalisation request to MHCLG on 15 December
  - Regular discussions continuing
  - MHCLG Improvement panel set up to assess submission
  - Circa 25 Councils in discussions with MHCLG regarding financial challenges
  - Estimated 10-12 Councils seeking capitalisation approval from MHCLG and HM Treasury
  - Government considering all requests individually, but also considering sector wide implications



## **Improvement Board / external support**

- Croydon Council is committed to establishing an Independent external Improvement Board to provide robust challenge and support
- Consultation underway regarding terms of reference and membership (report back to cabinet in February, Council in March)
- In addition to the Independent external Improvement Board, anticipate MHCLG will appoint additional external advisors to their own panel



## **Review of Companies - actions**

- Work continues on strategic review of companies and other entities
- Report to come to Cabinet in February with key recommendations
- Approach agreed through discussions with Scrutiny & Overview Committee and GPAC to seek External Audit value for money review of Fairfield Halls refurbishment



## **Delivering the improvement**

- Croydon Renewal Improvement Plan incorporates 434 projects / actions across 11 programmes
- Mobilising projects prioritising MTFS items first
- New reporting systems developed to support monitoring of progress and risks which will include improved reporting on Council wide performance
- Further budget challenge process to identify additional savings
- Asset review to confirm where the Council can reduce capitalisation request through disposals



## Key reports :

- There are a number of reviews / reports that the Council have been / are being carried out:-
  - Independent investigation by Richard Penn
  - MHCLG rapid review
  - Centre for Governance & Scrutiny (which is expected to inform Scrutiny work plan)
  - Each will have recommendations to incorporate into the Croydon Renewal Improvement Plan
